**b. Our insurer has stated that RCABC is the 'body' that has the knowledge and experience with respect to canoeing and paddling. Therefore, RCABC is entrusted to sanction only safe activities. RCABC has outlined safety standards and guidelines in the 2005 pamphlet, "A Guide to Canoeing Safety in British Columbia" <http://www.bccanoe.com> and in the RCABC 2010 Edition of the "Instruction Manual". As long as the activities proposed by your club fall under RCABC's approved guidelines, standards and activities, and PROVIDED the RCABC guidelines are followed, RCABC can 'sanction' the activities.**

**c. If it is unclear whether special events and/or extended trips may be covered, contact RCABC's Secretary at 8166 Betts Road, Wardner, B.C. V0B 2J0 in advance. It may take a few weeks to determine whether the event will be sanctioned.**
